# Q12

What, if any, are the key barriers to effective management of invasive species?

Primarily the State needs to decide how important biosecurity is to the nation and act accordingly. At a biosecurity weeds level, the state management system is over complicated, multi level and expensive before any actual on ground management takes place. Biosecurity funding is not guaranteed long term, is not regularly distributed and is inefficientl managed by Government departments long before any actual on ground activities can be budgeted. Insertion of the LLS into the system in á management role' was a pure political appointment and only serves to reduce the available funding with no practical gain. Local Government as the local control authority is the legislatively appointed operator required to be responsible yet is over administered and under funded. Whilst under the current system NSW will always play catch up. It is not possible to be in front of the game

## Q13

How has invasive species management changed since the introduction of the NSW Biosecurity Act 2015 legislation and associated programs and plans?

Using the risk based approach of the current legislation sounds all good. In practice all the load is on the bio security officer making that risk assessment, land managers see that as very subjective. Coupled with the legislation having the term 'where reasonably practicable' inserted in it, makes it very open to dispute or the option to provide limited management response based on capability.

### Q14

What are the future risks posed by invasive species to the NSW environment, industries and communities?

Significant risk to industry, amenity & lifestyle.

Evident in just 2 instances, Varroa & Fire Ant.

Less evident is the spread of aquatic weeds and the risk of internet bought plants. Internatinal markets are now heavily scrutinised. Any contamination in produce risks market access. Food security and our place in the international market place are at risk.

#### Q15

What opportunities do you see to improve the outcomes of invasive species management in the future?

Run national policies. Remove unnecessary bureaucracy and politics from the job. Adequately fund local government so that they can provide the front line staff required. Make Biosecurity funding a guaranteed, indexed, long term priority and pay it regularly, on time. Put Biosecurity activities together. Currently they are separated by management, funding and priority. Biosecurity, DPI, LLS, Local Government, Weeds, Pest animals etc. and all effected by politics driven by public opinion and votes. Some jobs are a basic necessity look at biosecurity more like defense of the nation, because that's what it is.
