A properly funded local level is the ONLY thing that hasn't been tried in this space, yet it is the only place in which eradication results have been achieved. Funding must be massively decentralised if we are to have any chance of making things better. The current funding and institutional structures have been proven to fail multiple times over.

Any other comments?

Every review seems to generate the same proven to fail structures again and again, with a new logo or department label. Funding for weeds must be decentralised with local government receiving funding directly from Treasury to meet strategic weeds targets incorporated into their broader Integrated Planning and Reporting framework. This will ensure adequate governance, reporting and commitment to tangible on-ground outcomes. This is a NEW model, something that hasn't been tried in over 100 years of state government weeds funding.
