Please find set out below my answers to the five key questions in relation to "social, economic and environmental outcomes and opportunities for improvement" as per your correspondence dated August 7, 2019.

To answer these questions, I printed out the Water Sharing Plan for the Peel Valley – current version – copy attached

### Question 1

To what extent do you feel the plan has contributed to social outcomes?

#### **ANSWER**

What social outcomes?

It appears that the Natural Resources Commission, Water NSW and Tamworth Regional Council have only got the city of Tamworth in mind for social outcome.

All three aforementioned identities have allowed the growth and social wellbeing of Tamworth city without any consideration towards establishing the necessary logistics for this growth.

New sub-divisions with "town water" have been approved at a rapid rate. Nowhere have any of the aforementioned identities allowed for additional water storage
